VENDOR agrees that BROKER is the agent of the respective owners of the managed properties. VENDOR agrees to hold BROKER, its employees, agents and assigns harmless for the failure of a property owner to pay for services, supplies, parts materials and/or labor ordered by owner and/or BROKER on behalf of or at the request of owner. VENDOR agrees that they shall do no other work on the property other than that which is specifically ordered and approved by owner and/or BROKER. VENDOR understands and agrees that the TENANT(s) have no authority whatsoever to order any work to be done on the premises.



VENDOR agrees not to discuss the nature of repairs ordered or the results of their service call with the TENANT, but to report all findings to the BROKER'S agent or the owner, if applicable.

- 1. You will respond to the person ordering your service within the day ordered or the following morning and be available to go to the property for the repair within 48 hours.
- 2. You will be prepared to show identification to the Tenant upon entering a unit.
- 3. You will not park in the driveway in case your vehicle is leaking fluids that may stain.
- 4. You will not discuss your opinions of the repair status of any appliance or system or fixture with the tenants, only with the Property Manager.
- 5. You will be courteous and politely spoken at all times when on the property.
- 6. You will not use the radio or TV of the tenants while at the property.

VENDOR agrees and affirms that it carries the proper insurance, licenses, and permits necessary to legally carry out the requested services and agrees to hold BROKER, its employees, agents and assigns harmless for any injuries suffered by or damages suffered by VENDOR, its employees, agents, and/or assigns arising out of performance of the requested services. VENDOR agrees to look solely to the owner of the premises where the services are performed in the event of any dispute over funds owed for services performed.
